



KINGSTON'S PET EXPO COLOURING COMPETITION TERMS & CONDITIONS

1. The name of the competition is "Kingston's Pet Expo Colouring Competition".
2. The Promoter of the Competition is City of Kingston (ABN 80 640 377 247) of 1230 Nepean Hwy, Cheltenham VIC 3192 ("the Promoter").
3. By submitting an entry into the Colouring Competition, guardians are signifying that they have read and agreed to these terms and conditions and entrants have consent of their guardian to enter.
4. The Competition will commence on Thursday 26 March 2025 and entries will close 11.45am on 29 March 2025 ("the Competition Period").
5. To enter the Competition, entrants must download the PDF colouring in page from the City of Kingston Pet Expo website, collect a colouring in sheet in person from Customer Service at 1230 Nepean Highway or complete a colouring in sheet at the Pet Expo. Entries must be handed in at the Kids Corner marquee on the day of the expo to be eligible to win. The Expo is being held at Kingston Heath Reserve, 285 Centre Dandenong Road, Cheltenham, Saturday 29 March 2025.
6. The Promoter accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise. The Promoter is not liable for any consequences of user error including (without limitation) costs incurred. All inaccurate and/or incomplete entries will be deemed invalid.
7. Each valid entry will be individually judged by representatives of the Promoter on the basis of originality and creativity.
8. The Promoter will be selecting one (1) winner on Saturday 29 March 2025 at the Expo. The most original and creative entry as judged by the Promoter will win a Toy and Book Pack.
9. Prize is not transferable and cannot be redeemed for cash. Prize must be taken as described and no compensation will be payable if the winner is unable to use the prize as described.
10. The Winner will be notified by email or phone on Monday 31 March 2024 if not present to collect prize. In the event that for any reason whatsoever the Winners do not respond to the prize notification by 5.00pm (AEDT) on 17 April 2025, then the prize will be forfeited by the Winner.
11. All entries become the property of the Promoter and will not be returned.
12. All entries must be the entrant's own work.
13. The Promoter reserves the right to request winners to provide proof of identity. Unless otherwise nominated, the winner's prize will be sent to the address held by the Promoter for the entrant.
