#### 1. Background

Following the resignation of the Chief Executive Officer, Julie Reid effective 12 February it is a requirement of section 95A of the Local Government Act 1989 and section 44(4) Local Government Act 2020 for Council to appoint an Interim Chief Executive whilst the recruitment process is being undertaken.

Following an expression of interest and interview process it is proposed to appoint <name> to the position.

The contract of employment allows for the termination of the agreement on 4 weeks written notice and provides for an option to extend the appointment – subject to a further Council resolution – if required, to allow Council the flexibility to negotiate a start date following the formal recruitment process.
