"With the completion of the Bay Trail finally in sight, after a 20 year wait it is already proving itself to be one of the most utilised and successful recreation trails in the region. This is a credit to this council's determination to complete the trail, while preserving the local environment's significant coastal vegetation. Are there plans to improve the area around Pier Road, the Hazel Pierce Reservation and the linkage to Pompei's Landing?"

## The General Manager Planning and Development provided the following response,

"I would like to thank Mr. Falkingham for his question and acknowledge his feedback regarding the Bay Trail. The Council is scheduled over the coming couple of months to commence a further planning process for the Peter Scullin and Hazel Pierce Reserves. This process will provide further opportunity for community comment with an ability then to brief the Council on opportunities to further enhance these areas and provide connections into Pompei's landing. Council will also be looking at a range of minor upgrades to some of the existing building stock located within the reserves over coming years."
