That Council, pursuant to Section 20(2) or 20(4) of the Planning and Environment Act 1987 request the Minister for Planning to prepare, adopt and approve an amendment to the Kingston Planning Scheme, to rezone 19 Tarella Road, Chelsea from a General Residential Zone (Schedule 3) to a Public Park and Recreation Zone (PPRZ) and that this been done as soon as practically possible.

That Council, pursuant to Section 20(2) or 20(4) of the Planning and Environment Act 1987 request the Minister for Planning to prepare, adopt and approve an amendment to the Kingston Planning Scheme, to rezone 19 Tarella Road, Chelsea from a General Residential Zone (Schedule 3) to a Public Park and Recreation Zone (PPRZ) and that this been done as soon as practically possible.

Further, that officers undertake the following without delaying the rezoning:

- commission the consultant who provided the ecological assessment for the 2020 VCAT case to undertake an Environmental Management Plan for the site (subject to a report to Council's first CIS and Ordinary Meetings after the caretaker period if the cost is likely to exceed \$25,000.)
- ensure that the site is managed along similar lines to the Bradshaw Nature Reserve, with due emphasis on the environmentally significant natural resources on the site;
- that an Open Day be organised as soon as possible in the light of the Covid19 constraints - to give our residents and ratepayers the opportunity to appreciate the values of this future parkland first hand;
- that all petitioners who signed the petition to Council regarding this land be invited to the Open Day;
- that the draft Ecological Assessment prepared as an expert witness statement by Biosis consultants for the 2020 VCAT case be made public once it is finalised and be sent out with the Open Day invitations if possible.
